


Amaxa™ 4D-Nucleofector™ Protocol for HeLa cells

For 4D-Nucleofector™ X Unit—Transfection in suspension

Human cervix adenocarcinoma, adherent epithelial cell line

Example for Nucleofection™ of HeLa cells

Transfection efficiency and viability of HeLa cells 24 hours post Nucleofection™. HeLa cells were transfected with program CN-114 and 0.4 µg of pmaxGFP™ Vector in 20 µl Nucleovette™ Strips. 24 hours post Nucleofection™ cells were analyzed on a FACSCalibur™ (Becton Dickinson). Cell viability was determined as % PI negative cells.

Storage and stability

Store Nucleofector[™] Solution, Supplement and pmaxGFP[™] Vector at $4\,^{\circ}$ C. For long-term storage, pmaxGFP[™] Vector is ideally stored at -20 °C. The expiration date is printed on the solution box. Once the Nucleofector[™] Supplement is added to the Nucleofector[™] Solution, it is stable for three months at $4\,^{\circ}$ C.

Note

4D-Nucleofector™ Solutions can only be used with Nucleocuvettes™ (conductive polymer cuvettes), i.e. in the 4D-Nucleofector™ System and the 96-well Shuttle™ Device. They are not compatible with the Nucleofector™ II/2b Device.

Required Material

Note

Please make sure that the entire supplement is added to the Nucleofector $^{\text{\tiny{M}}}$ Solution. The ratio of Nucleofector $^{\text{\tiny{M}}}$ Solution to supplement is 4.5 : 1 (see table 1)

- 4D-Nucleofector™ System (4D-Nucleofector™ Core Unit and 4D-Nucleofector™ X Unit)
- Supplemented 4D-Nucleofector™ Solution at room temperature
- Supplied 100 µl single Nucleocuvette™ or 20 µl 16-well Nucleocuvette™
 Strips
- Compatible tips for 20 µl Nucleocuvette™ Strips: epT.I.P.S. [US/CDN: Eppendorf North America, Cat. No. 2491.431, Rest of World: Eppendorf AG, Cat. No. 0030073.266], Matrix TallTips® [Matrix Technologies Corp., Cat. No. 7281] or LTS Tips [Rainin Instruments, LLC, Cat. No. SR-L10F, SR/SS-L250S, SR/SS-L300S]. Before using other types of pipette tips, please ensure they reach the bottom of the Nucleocuvette™ Wells without getting stuck
- Supplied pmaxGFP™ Vector, stock solution 1μg/μl

Note

For positive control using pmaxGFP $^{\text{m}}$, dilute the stock solution to an appropriate working concentration. Further details are provided in table 3 of this Optimized Protocol. The volume of substrate solution added to each sample should not exceed 10% of the total reaction volume (2 μ l for 20 μ l reactions; 10 μ l for 100 μ l reactions).

- Substrate of interest, highly purified, preferably by using endotoxinfree kits: A260:A280 ratio should be at least 1.8
- Cell culture plates of your choice
- For trypsinization: 0.5 mg/ml Trypsin and 0.2mg/ml EDTA in PBS and supplemented culture media or PBS/0.5 % BSA
- Culture medium: 90 % MEM (Minimum Essential Medium with Earle's salts) [Lonza; Cat. No. BE12-125F] with 2 mM Ultraglutamine I [Lonza, Cat. No. BE17-605E/U1], 100 U/mI Penicillin, 100 µg/mI Streptomycin, 0.1 mM non-essential amino acids, 0.1 mM sodium pyruvate and 10 % FCS
- Prewarm appropriate volume of culture medium to 37 °C (see table 2)
- Appropriate number of cells/sample (see table 2)

1. Pre Nucleofection™

Cell culture recommendations

- 1.1 Seeding conditions: 2-3 x 10³ cells/cm²
- 1.2 Replace media 2–3 per week (20–30 ml medium per 162 cm² flask)
- 1.3 Passage cells after reaching 90 % confluency
- 1.4 Cells should be passaged 3 days before Nucleofection™ depending on growth rate
- 1.5 Optimal confluency before Nucleofection™: 70–80 %

Trypsinization

- 1.6 Remove media from the cultured cells and wash cells once with PBS; use at least same volume of PBS as culture medium
- 1.7 For harvesting the cells, incubate the cells at 37 °C with 0.5 mg/ml trypsin/0.2 mg/ml EDTA
- 1.8 Inactivate trypsinization reaction with supplemented culture medium or PBS/0.5 % BSA

2. Nucleofection™

For Nucleofection™ Sample contents and recommended Nucleofector™ Program, please refer to Table 3.

- 2.1 Please make sure that the entire supplement is added to the Nucleofector™ Solution
- 2.2 Start 4D-Nucleofector™ System and create or upload experimental parameter file (for details see device manual)
- 2.3 Select/Check for the appropriate Nucleofector™ Program (see table3)
- 2.4 Prepare cell culture plates by filling appropriate number of wells with desired volume of recommended culture media (see table 4) and pre-incubate/equilibrate plates in a humidified 37 °C/5 % CO₂ incubator
- 2.5 Pre-warm an aliquot of culture medium to 37 °C (see table 4)
- 2.6 Prepare plasmid DNA or pmaxGFP™ Vector or siRNA (see table 3)
- 2.7 Harvest the cells by trypsinization (please see 1.6–1.8)
- 2.8 Count an aliquot of the cells and determine cell density
- 2.9 Centrifuge the required number of cells (see table 3) at 90xg for 10 minutes at room temperature. Remove supernatant completely
- 2.10 Resuspend the cell pellet carefully in room temperature 4D-Nucleofector™ Solution (see table 3)
- 2.11 Prepare mastermixes by dividing cell suspension according to number of substrates
- 2.12 Add required amount of substrates to each aliquot (max. 10 % of final sample volume)
- 2.13 Transfer mastermixes into the Nucleocuvette™ Vessels

Note

As leaving cells in Nucleofector™ Solution for extended periods of time may lead to reduced transfection efficiency and viability it is important to work as quickly as possible. Avoid air bubbles while pipetting.

- 2.14 Gently tap the Nucleocuvette™ Vessels to make sure the sample covers the bottom of the cuvette
- 2.15 Place Nucleocuvette™ Vessel with closed lid into the retainer of the 4D-Nucleofector™ X Unit. Check for proper orientation of the Nucleocuvette™ Vessel
- 2.16 Start Nucleofection™ Process by pressing the "Start" on the display of the 4D-Nucleofector™ Core Unit (for details, please refer to the device manual)
- 2.17 After run completion, carefully remove the Nucleocuvette™ Vessel from the retainer
- 2.18 Resuspend cells with pre-warmed medium (for recommended volumes see table 5). Mix cells by gently pipetting up and down two to three times. When working with the 100 µl Nucleocuvette™ use the supplied pipettes and avoid repeated aspiration of the sample
- 2.19 Plate desired amount of cells in culture system of your choice (for recommended volumes see table 5)

3. Post Nucleofection™

3.1 Incubate the cells in humidified 37 °C/5 % $\rm CO_2$ incubator until analysis. Gene expression or down regulation, respectively, is often detectable after only 4–8 hours
